I am writing to submit to you a complaint, and inform you of a violation of the PEMRA Code of Conduct 3. (1)(a) Which states that: No content is aired that: Is against the Islamic values, ideology of Pakistan or founding fathers of the nation including Quaid-e-Azam and Dr Allama Muhammad Iqbal. Which has been violated by the ARY network in its portrayal of two individuals of the opposite gender and who have no marriage contact (both in the script or in real life) touching one another (a woman is seen combining the hair of a na-Mehram) in the dreams serial 'RAD'. This portrayal of two na-Mehram seductively touching one another on live television is in clear violation of the values of Islam, which strictly prohibits not only the act which was portrayed in the drama RAD: ""</p> <p>It was narrated that Ma'qil ibn Yassar said: the Messenger of Allaah (peace and blessings of Allah be upon him) said: "For one of you to be stabbed in the head with an iron needle is better for him than that he should touch a woman who is not permissible for him." Narrated by al-Tabaraani in al-Kabeer, 486. Shaykh al-Albaani said in Saheeh al-Jaami', 5045, that this hadeeth is saheeh. More importantly, and what's more concerning is the fact that this was aired throughout the country for to people to see and can be clearly identified as an attempt to induce and promote behaviours of sexual immortality and degeneracy amongst the masses, against which Allah mentions in the Quran: (24:19) Verily those who love that indecency should spread among the believers deserve a painful chastisement in the world and the Hereafter. Allah knows, but you do not know.</p> <p>I restart for immediate action to be taken against the ARY network for the violation of the values and teachings of Islam the regulatory limits defined by PEMRA, and for attempting to induce degeneracy amongst the masses.
