AUTHORITY MEETINGS

Three Authority Meetings were held at PEMRA Headquarters from January to March 2015. 101st Authority Meeting was held on January 16, 2015, 102nd Authority Meeting was held on February 20, 2015 and 103rd Authority Meeting was held on March 27, 2015. Some salient decisions are as under;

- Award of Consultancy Services for Direct to Home (DTH) to M/s Digital Strategy Consulting & Services (Pvt.) Ltd Switzerland.
- Cancellation of Dormant Cable TV Licences and publication of final public notice in national dailies besides providing opportunity of claim to licensees for 15 days.
- Request of a satellite TV channel for change in Content / Program mix was regretted.
- Change in logo / channel name of M/s Central Media Network (Pvt.) Ltd was approved subject to compliance of programming mix.
- Rs. 200,000/- fine was imposed on a satellite TV channel besides warning for violating License Terms & Conditions.
- Matter of a satellite TV channel regarding payment defaults, unauthorized change of logo/design without approval of Authority was referred to Council of Complaints for its recommendations.
- Rs. 100,000/- fine was imposed on five satellite TV channels for airing excessive foreign content followed by warning.
- Rs. 300,000/- fine was imposed on a satellite TV channel for airing unedited live objectionable remarks.
- Non-Commercial FM radio license was approved for Liaquat University of Medical & Health Sciences, Jamshoro, Sindh.
- Landing rights permission of foreign channel "AXN" was renewed for another five years.
- Revised budget for F.Y. 2014-15 and budget estimates for F.Y. 2015-16 were approved.

MEDIA WORKSHOP AT ISLAMABAD

Executive Member PEMRA Kamal Uddin Tipu attended Media Workshop organized by Friedrich Eberto Stiftung at a local hotel at Islamabad on January 21, 2015. The workshop gathered veteran media professionals, journalists, academicians and parliamentarians

to discuss the growth and future of media in the light of recommendations of the Media Commission headed by former Senator and Information Minister Javed Jabbar. Impediments to growth of media were discussed.

- Speakers called for improved self-censorship, feedback, ethics and language, which they opined, are getting weaker while corporate interests are getting stronger.
- Participants lauded the recommendations of Media Commission report and asked for its implementation.




PEMRA OFFICERS ATTEND CABSAT EXHIBITION AT DUBAI (MARCH 9-11, 2015)
